The East 15 feet of Lot 45, all of Lot 46, and the West 3 feet of the North 89 feet of Lot 47, Block 3, EMERSON HEIGHTS ADDITION, according to the plat thereof, as recorded in the office of the County Recorder of said County.

TOGETHER WITH 1/2 the vacated alley abutting said property on the South.

and WHEREAS, there exists a right of way and easement for a joint driveway over and across the East 15 feet of the following described property:

The East 15 feet of Lot 45, all of Lot 46, and the West 3 feet of the North 89 feet of Lot 47, Block 3, EMERSON HEIGHTS ADDITION, according to the plat thereof, as recorded in the office of the County Recorder of said County.

Maintenance includes, but is not limited to snow and ice removal, removal of any and all debris and any repairs necessary to keep said right of way and easement operational.

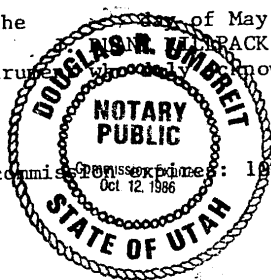
