EASEMENT

Logan City Corporation, a municipal corporation, a corporation doing business in the State of Utah, Grantor, hereby conveys to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Cache County, Utah. Along a center line described as follows:

Beginning at the west right of way line of 15th North Street at a point 31 feet south and 887 feet east, more or less, from the north one quarter corner of Section 26, T. 12 N., R. 1 E., S.L.M., and running thence N. 88°18' W. 850 feet, more or less, to an existing pole on the Grantor's land and being in the NW 1/4 of the NE 1/4 of said Section 26.

One guy anchor located on the Grantor's land at a point 47 feet south and one foot west, more or less, from the northeast corner of Lot 6, Block 21, Plat G, Logan Farm Plat, and being in said Lot 6.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
