QUIT CLAIM DEED.

This Indenture Made 30th day of October, one thousand nine hundred and eighteen (1918) between the Promontory Ranch Company, a corporation organized and doing business under the laws of the State of California, and having its principal place of business at San Francisco, California, the party of the first part, and Promontory-Curlew Land Company, a corporation, the party of the second part,

Witnesseth, That the party of the first part, for and in consideration of the sum of Ten (10) Dollars, Gold Coin of the United States of America, to it in hand paid, by party of the second part, the receipt whereof is hereby acknowledged, hereby releases and Quitclaims, unto the party of the second part, all those certain lots, pieces or parcels of Land situate in the County of Box Elder, State of Utah, and bounded and described as follows, to-wit:

In Township Eight (8) North , Range Seven (7) West, Salt Lake Meridian Lots One (1), Two (2), Three (3) and Four(4) of Section One (1): Sections Three (3) and Five (5) Lots One (1) Two (2), Three (3) Four (4), Five (5) and West Half of North West Quarter (W $\frac{1}{2}$ of NW $\frac{1}{4}$) Section Nine (9)

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder, and remainders, rents, issues and profits thereof,

To Have And To Hold, all and singular the said premises, together with the appurtenances, unto the party of the second part and to its successors and assigns forever.
