AMENDMENT TO DECLARATION OF BUILDING AND USE RESTRICTIONS

WHEREAS, the undersigned are all of the owners of the following described real property located in the County of Salt Lake, State of Utah:

ALL of Lots 101 to 140 inclusive CONTADORA ESTATES, PLAT 1, according to the official plat thereof, as recorded in the office of the County Recorder of said County; and

ALL of Lots 201 to 236 inclusive CONTADORA ESTATES, PLAT 2, according to the official plat thereof, as recorded in the office of the County Recorder of said County.

WHEREAS, the property described herein is subject to certain covenants and restrictions as set forth in that certain document entitled "Declaration of Building and Use Restrictions" dated January 10, 1980 and recorded January 11, 1980 as Entry No. 3387150 in Book 5024 at pages 17 through 19 of the official records of the Salt Lake County Recorder; and

WHEREAS, the undersigned are desirous of amending the terms of paragraph 3 of part B of said Declaration to reduce the main floor square footage requirement.

THEREFORE, the undersigned hereby agree that paragraph 3 of part B of the Declaration of Building and Use Restrictions shall be amended to read as follows:

3: Dwelling quality and size. It is the intention and purpose of the covenants to assure that all dwellings shall be of a quality of workmanship and materials substantially the same as the dwellings existing in the subdivision on the date of this amendment. The main floor area of the main structure, exclusive of one-story open porches and garages, shall not be less than 875 square feet. All dwellings constructed subsequent to the date of this amendment shall have a maintenance free exterior. In addition, the dwellings constructed on Lots 118, 121, 124, 126, and 127 must have two car garages and the dwelling constructed on Lot 119 must have a single car garage.

FURTHERMORE, the undersigned do hereby declare that the Declaration of Building and Use Restrictions, as herein amended, shall hereafter control the use and enjoyment of all parcels of real property described herein.
