partnership doing business in the State of Utah, Grantor, hereby conveys, warrants and grants to PacificCorp, an Oregon corporation, dba Utah Power & Light Company, whose principal place of business is located at 1407 West North Temple, Salt Lake City, Utah, its successors in interest and assigns, Grantee, for the sum of Ten (\$10.00) Dollars and other valuable consideration, a perpetual easement and right of way for the erection, operation, maintenance, repair, alteration, enlargement, inspection, relocation and replacement of electric transmission and distribution lines, communications circuits, fiber optic cables and associated facilities, and four poles and no guy anchors, with the necessary guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said lines and circuits, on, over, under and across real property located in Utah County, Utah, described as follows:

A right of way 10 feet in width, being 5 feet on each side of the following described survey line:

Beginning on the easterly boundary line of the Grantor's land at a point 400 feet south and 365 feet west, more or less, from the east one quarter corner of Section 15, T.5 S., R.1 E., S.L.M. thence N.63°05'W 790 feet, more or less, to the westerly boundary line of said land, and being in the NE 1/4 of the SE 1/4 of said Section 15.

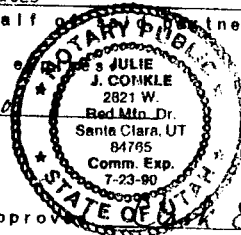
