CERTIFICATE OF AUTHORITY TO AMEND THE  
SURVEY MAP FOR TOWER HILL CONDOMINIUM

In accordance with paragraph 24 of the Declaration of Covenants, Conditions, Restrictions, and By-Laws of Tower Hill Condominium, the Management Committee of Tower Hill Condominium, by and through its president, Bernice Evans, who has been duly authorized to so act, CERTIFIES as follows:

1. That at a meeting of the Tower Hill Home Owners Association held February 17, 1983, a vote of approval and consent of the unit owners representing not less than two-thirds (2/3) of the undivided interest in the common areas and facilities of Tower Hill Condominium, authorized the following amendments of the Record of Survey Map for Tower Hill Condominium:

(a) Sheet 2 of said Map shall be amended to show the existence of a limited common area storage closet and space located in the basement between parking stalls P500 and P501 and shall be marked S-500 and said sheet 2 shall be further amended to show the following notation thereon:

"The storage closet and area in the basement marked S-500 is limited common ownership and is assigned to unit 500."

(b) Sheet 3 of said Map shall be amended to show the existence of a limited common area storage closet and space located on the 5th floor, and such closet and space shall be marked <sup>S</sup>500; and said sheet 3 shall further be amended to show the following notation thereon:

"On the 5th floor the storage closet and area marked <sup>S</sup>500 is

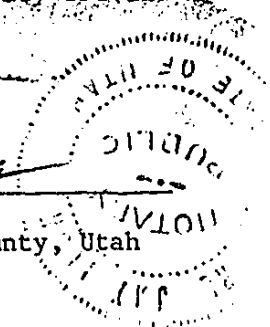
