**MEMORANDUM OF MODIFICATION AGREEMENT
AMENDING SECURITY INSTRUMENT
AND ADDENDUM TO SECURITY INSTRUMENT**

IVORY RIDGE WEST OFFICE, LLC, a Utah limited liability company ("Borrower" or "Trustor") and WELLS FARGO BANK, NATIONAL ASSOCIATION ("Lender") have entered into a Modification Agreement dated of even date herewith ("Modification Agreement"), wherein provision is made for (a) amendment of that certain Construction Deed of Trust with Absolute Assignment of Leases and Rents, Security Agreement and Fixture Filing dated December 22, 2014, and executed by Borrower, as Trustor, in favor of WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION, as Trustee, for the benefit of Lender, as Beneficiary, which was recorded on December 30, 2014 as Entry No. 94185:2014 of the official real property records of the Utah County Recorder's Office in the State of Utah ("Security Instrument"); and/or (b) amendment of certain obligations secured by the Security Instrument. The Security Instrument encumbers that certain real property described in Exhibit A attached hereto and by this reference made a part hereof.

The Security Instrument secures, among other things, that certain Amended and Restated Promissory Note Secured by Deed of Trust of even date herewith, executed by Trustor, as "Borrower", and payable to the order of Lender, in the principal amount of Four Million Four Hundred Ten Thousand Eighty-Five and No/100ths Dollars (\$4,410,085.00) (as the same may be amended, modified, supplemented and/or replaced from time to time, the "Amended Note"). All references in the Security Instrument to the "Note" are hereby amended to refer to the Amended Note.

This instrument is a memorandum of the modification agreement, and the same is incorporated herein by this reference with the same effect and as though set forth herein in its entirety.






