right-of-way 15 feet in width, and a temporary easement right-of-way 40 feet
in width for construction purposes, to the use of the Grantors land for the
construction, operation, and maintenance of a water distribution system and
appurtenant works, upon, across, and over the lands, hereafter described, to-
gether with the right to excavate and fill trenches for the location and
maintenance of said distribution system and the further right to remove trees,
bushes, and undergrowth and obstructions interfering with the location, con-
struction, and maintenance of said distribution system and appurtenant works
constructed thereon by the HIGH CREEK CULINARY WATER SYSTEM by virtue of and
pursuant to an agreement by and between the State of Utah, acting through the
BOARD OF WATER RESOURCES and the HIGH CREEK CULINARY WATER SYSTEM for the con-
