TRANSFER AND CONVEYANCE

The State of Utah, acting through the BOARD OF WATER RESOURCES, GRANTOR, formerly the Utah Water and Power Board, for the full payment of the purchase price, receipt of which is hereby acknowledged, of various Agreements, with Lake Creek Irrigation Company, a corporation of the State of Utah, does hereby transfer and convey to LAKE CREEK IRRIGATION COMPANY, the following easements and rights-of-way together with the right of ingress into and egress from said properties, to-wit:

1. A perpetual easement of sufficient width and length for the construction, operation, and maintenance of a concrete-lined canal, the Center Line beginning as follows:
