AMENDMENT

AMENDMENT to "Protective Covenants, Agreements, Restrictions and Conditions Affecting the Real Property Known as Springwater Park Subdivision".

WHEREAS, the undersigned are the legal and beneficial owners in fee simple of a certain tract of land situated in Utah County, State of Utah, described as SPRINGWATER PARK SUBDIVISION, or of lots therein, and

WHEREAS, a "Declaration of Protective Covenants, Agreements, Restrictions and Conditions Affecting the Real Property Known as Springwater Park Subdivision" has been filed of record in the office of the Utah County Recorder and whereas the undersigned desire to amend the said declaration pursuant to the terms thereof:

NOW, therefore, the undersigned declare that the aforesaid declaration shall be and hereby is amended to delete paragraph 2 entitled Dwelling Costs, Quality and Size and insert in its stead the following paragraph:

2. Dwelling Costs, Quality and Size. No dwelling shall be permitted on any lot at a cost of less than Fifty-Thousand Dollars (\$50,000.00) based upon cost levels prevailing on the date the aforesaid declaration was recorded, it being the intention and purpose of the covenant to insure that all dwellings shall be of a quality of workmanship and materials substantially the same or better than that which can be produced on the date the aforesaid declaration was recorded at the minimum cost stated herein for the minimum permitted dwelling size. The finished area of the main structure, exclusive of one story open porches and garages, shall be not less than 1,000 square feet.

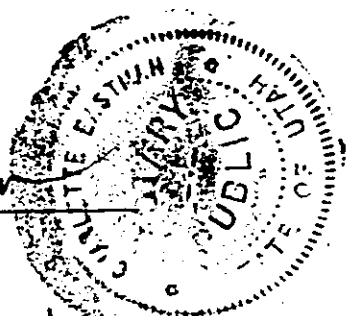

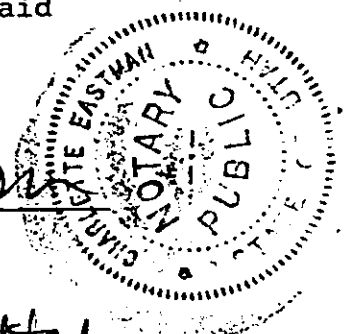

WHEREAS, a "Declaration of Protective Covenants, Agreements, Restrictions and Conditions Affecting the Real Property Known as Springwater Park #A" has been filed of record in the office of the Utah County Recorder and whereas the undersigned desire to amend the said declaration pursuant to the terms thereof:

Now, therefore, the undersigned declare that the aforesaid declaration shall be and it hereby is amended to delete paragraph C-3 entitled DWELLING COSTS, QUALITY AND SIZE and insert in its stead the following paragraph:

C-3. DWELLING COSTS, QUALITY AND SIZE. No dwelling shall be permitted on any lot at a cost of less than thirty-two thousand dollars exclusive of the lot, based upon cost levels prevailing on the date the declaration of protective covenants was recorded, it being the intention and purpose of the covenant to assure that all dwellings shall be of a quality of workmanship and materials substantially the same or better than that which can be produced on the date the said declaration was recorded at the minimum costs stated herein for the minimum permitted dwelling size. The finished area of the main structure, exclusive of open porches and garages, shall be not less than 1,000 square feet.
