Specifically, the parcel is a division and/or subdivision of a larger Parcel and was not created in compliance with the requirements established by the Utah State Code and/or The Box Elder County Land Use Management and Development Code for such divisions. Therefore, Box Elder County cannot verify that this property has services available, is accessible without trespass and therefore may not be able to issue a building permit for a structure on the property.


