## NOTICE OF REINVESTMENT FEE COVENANT

(The Exchange in Lehi Condominiums Phase 13 Plat 'N')

Pursuant to Utah Code Ann. § 57-1-46(6), the Exchange in Lehi Condominium Owners Association, Inc. ("Association") hereby provides this Notice of Reinvestment Fee Covenant which burdens all of the real property described in Exhibit A (the "Burdened Property"), attached hereto, which is subject to the Declaration of Condominium for The Exchange in Lehi Condominiums recorded with the Utah County Recorder on April 12, 2017 as Entry No. 35362:2017, and any amendments or supplements thereto (the "Declaration").
