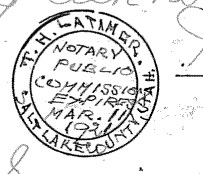

Beginning at the Southeast corner of Section 13, Township 3 South, Range 1 West of S. 2. Merid; and running thence West 80 rods; thence North 40 rods; thence East 89 rods; thence South 40 rods; thence West 9 rods to point of beginning county of Salt Lake and State of Utah with the right to permit the attachment of the wires and fixtures of any other companies, and to trim any trees along said lines so as to keep all wires cleared at least thirty-six inches.
