AMENDMENT TO DECLARATION OF PARTRIDGE PUACE

NOW, THEREFORE, the Declaration of Partridge Place is hereby amended as follows:

- 1. Section 19 entitled "Sale or Lease; Right of First Refusal" is deleted in its entirety and with all of its subparts through and including subpart 19.9.
- 2. Section 19 of the Declarations is hereby amended to read, in its entirety, as follows:

19. Sale or Lease of Unit; Unit Owner's Responsibilities

- (19.1) Any unit owner may sell a unit and any unit owner may lease their unit provided that the lease shall be in writing and be for an initial term of six (6) months or more.
- (19.1.1) A unit owner shall notify the Management Committee of the site or lease of the unit and shall provide the Management Committee with the name and address of the purchaser or lessee and, in the event of the leasing of the unit, with a copy of the lease.

- (19.2) Each unit owner shall be responsible for the compliance with the provisions of this Declaration and of the Bylaws and House Rules of the Association by all occupants of, guests in, or visitors to such unit owner's unit.


