DESIGNATION OF MEMBERS OF ARCHITECTURAL COMMITTEE

KNOW ALL MEN BY THESE PRESENTS:

First, on the 15th day of August, 1978, the undersigned, Sherman D. Harmer, Jr., duly executed that document titled "MAJESTIC CANYON ESTATES NO. 2, Restrictive Covenants", which was subsequently recorded on August 16, 1978, at Book 4723, Pages 1489 through 1492, as Entry No. 3154925, in the office of the Salt Lake County Recorder, regarding the following described real property situated in Salt Lake County:

"Lots 1 through 65, Majestic Canyon Estates No. 2, a subdivision, according to the official plat filed in Book 78-7 of plats at page 207, records at the office of the Salt Lake County Recorder"

Second, pursuant to said document, an architectural committee was duly established, consisting of Lat-Low Realty & Construction, Incorporated, and other members selected by them, consisting of: Sherman D. Harmer, Jr.; Mark Low; and Mac Bay. Since that date, Lat-Low Realty & Construction, Incorporated, has ceased to function, Mark Low has died, and Mac Bay has resigned and left the state on an L. D. S. mission, leaving the undersigned Sherman D. Harmer, Jr., as the remaining member of said architectural committee.

Third, Sherman D. Harmer, Jr., as the remaining member of said architectural committee, has duly designated certain representatives with full authority, pursuant to said document, to review and approve or disapprove proposed building plans, specifications and plot plans for buildings to be erected, placed, or altered on any premises in said development, as to conformity and harmony of external design with existing structures in the development, and as to location of such building with respect to topography and finished ground elevation.


