his wife, Grantor, S., do... hereby convey... to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Cache County, Utah, along the following described center line:

Beginning at a new pole in an existing power line on the Grantor's land at a point 1320 feet South and 40 feet West, more or less, from the northeast corner of Section 36, T. 12 N., R. 2 W., S.L.M., thence S. 89°05'W. 2200 feet, thence S. 39°23'W. 2470 feet on said land and being in the S $\frac{1}{2}$  of the NE $\frac{1}{4}$ , the SE $\frac{1}{4}$  of the NW $\frac{1}{4}$  and the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of said Section 36.
