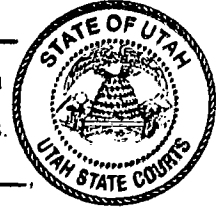

4. The amount of the judgment as filed is \$250,000.00, less any previous payments made by Defendant to Plaintiff, plus post-judgment interest at 10% per annum.

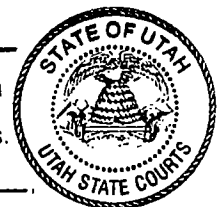
