# SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM

THIS SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OF 27TH STREET CONDOMINIUMS, hereinafter referred to the "Second Amendment," is made and executed this day of June, 1985, by HITO INTERNATIONAL CORPORATION, a Utah corporation, hereinafter referred to as the "Declarant."

# RECITALS:

- A. Declarant has heretofore recorded a certain document entitled Declaration of Condominium of 27th Street Condominiums (hereinafter the "Declaration") and a Record of Survey Map of 27th Street Condominiums, on November 1, 1983, as Entry No. 5503, page 2563, in the Office of the County Recorder of Salt Lake County, State of Utah.
- B. Section 7.1 of the Declaration provides that Declarant has the right and option, without the prior consent of the owners of the Association of Unit Owners, to expand 27th Street Condominiums at any time prior to the expiration of seven years from the date of recording of the Declaration (the "Option").
- C. Declarant desires to exercise and hereby does exercise the Option as provided in this Second Amendment.

- 5. Unless the context otherwise requires and except as otherwise provided herein, all terms defined in the Declaration shall have such defined meanings when used herein.
- 6. Except as expressly provided in this Second Amendment, the Declaration and all appendices thereto, shall remain in full force and effect in accordance with the provisions thereof.
- 7. This Second Amendment shall become effective when recorded in the Office of the County Recorder of Salt Lake County, State of Utah.
