that, pursuant to the Act of Congress, approved 20th May 1862 "To secure Non-vested to Actual Settlers on the
Public Domain", and the acts supplemental thereto, the claim of Ingeval Olson has been established and duly
consummated, in conformity to law for the South West quarter of the North West quarter, and the
South East quarter of the South West quarter of Section Twelve, in Township four North of Range
one East of Salt Lake Meridian in Utah, containing one hundred and sixty acres, according to
the official plat of the Survey of the said land, returned to the General Land Office by the Surveyor

Now know ye, that there is therefore granted by the United States to the said Ingeval Olson

And there is reserved from the lands hereby granted, a right of way thereon for ditches or canals constructed by the authority of the United States.
