The STATE OF UTAH, by and through Parks and Recreation, a Division of the Department of Natural Resources, of the State of Utah, by its duly appointed and qualified Director, Grantor, of Salt Lake City, in the County of Salt Lake, State of Utah hereby QUIT CLAIMS to Sterling B. Larson, Grantee, of Salt Lake City, County of Salt Lake, State of Utah, for the sum of Ten (\$10.00) Dollars, and other good and valuable considerations, all its right, title, and interest in and to the following described tract of land located in Salt Lake County, State of Utah, to wit:

A parcel of land in fee, being all of an entire tract of property, in Lot 6 of Section 11, T. 3 S., R. 1 W., S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning at a point in the center of Florence Way, which point is 75.25 rods north and 102 rods east and 958.47 feet S.  $89^{\circ}39'$  E. and 206.26 feet N.  $0^{\circ}05'05''$  W. thence 149.48 feet northeasterly along a 175' radius curve to the left and 88.202 feet N.  $40^{\circ}58'31''$  E. thence 277.59 feet northeasterly along a 200' radius curve to the right thence 25.00 feet S.  $62^{\circ}22'$  E. and 79.185 N.  $27^{\circ}38'$  E. from the SW. corner of Sec. 11 T. 3 S., R. 1 W., S.L. Mer., and thence running N.  $60^{\circ}16'47''$  W. 238 feet more or less, thence N.  $29^{\circ}43'$  E. 90 feet more or less, thence S.  $60^{\circ}16'47''$  E. 234 feet, more or less, thence S.  $27^{\circ}38'$  W. 90.06 feet to the point of beginning.

Subject to the following described road right-of-way: Beginning at the above described point of beginning and running N.  $60^{\circ}16'47''$  W. 25.017 feet thence N.  $27^{\circ}38'$  E. 90.06 feet S.  $60^{\circ}16'47''$  E. 25.017 feet thence S.  $27^{\circ}38'$  W. 90.06 feet to the point of beginning.

Together with a Right of Way for Road known as Florence Way and Charlotte Drive.

Together with any and all water rights pertaining to the above described parcel of land.

The Grantor hereby reserves all oil, gas, geothermal resources, coal, and all other mineral rights which are appurtenant to said land with the understanding that the Grantor reserves no surface occupancy or surface access rights with regard to the exploration for or extraction of the minerals or mineral estate.


