GRANT OF EASEMENT


GARY E. COLE, INC., Grantor, hereby grants, conveys and warrants to Park City Municipal Corporation, a political subdivision of the state of Utah, for the sum of Ten Dollars and other good and valuable consideration, the perpetual right, privilege and authority to operate, repair, replace and maintain a sidewalk including all necessary appurtenances, including utilities, located under, across, or upon the property owned by Grantor; said property being more particularly described as follows:

Beginning at a point which is South 1473.36 feet and East 1127.53 feet from the west quarter corner of Section 9, Township 2 South, Range 4 East, Salt Lake Base and Meridian; said point of beginning also being on the westerly right-of-way line of State Highway U-224 and the southeasterly corner of the Park Avenue Condominiums, as recorded, and running thence along said westerly right-of-way line South 24 degrees 00'00" East 148.00 feet to a point on a 45.00 foot radius curve to the right, whose center bears South 66 degrees 00'00" West; thence southwesterly along the arc of said curve 23.50 feet thru a central angle of 29 degrees 55'35"; thence North 24 degrees 00'00" West 170.45 feet to a point on the southerly boundary line of said Park Avenue Condominiums; thence along said southerly boundary line North 66 degrees 00'00" East 6.00 feet to the point of beginning.

TO HAVE AND TO HOLD the same unto the said Grantee, its successors and assigns, with the right of ingress and egress to and from and along said easement to maintain and operate, install, repair, inspect, use, protect, remove and replace the same. Grantors shall have the right to use said premises except for the purpose for which this right-of-way and easement is granted to the said Grantee, provided such use does not interfere with the facilities or any other rights granted to the grantee hereunder. Grantor hereby certifies it is the owner of the property described above.


