RELEASE AND GRANT OF EASEMENT.

For and in consideration of the sum of \$200.00 this day paid to the undersigned, receipt of which is hereby acknowledged, the undersigned and each of them hereby release and discharge the Utah & Salt Lake Canal Company, a corporation of Utah, and the Utah Copper Company, a corporation of New Jersey, and each of them, and the successors and assigns of each of them, from any and all claims, demands and causes of action whatsoever in favor of the undersigned or either of them, and against said corporation or either of them, for any and all loss or damages done or suffered to the land hereinafter described of the undersigned and occasioned or resulting from or by reason of the enlargement of the portion of the canal of said canal company extending through said land, or the construction of the embankment along the westerly line of the aforesaid portion of said canal, or the construction of the drains under or through said embankment, or the flooding of said land by waters of said canal.

And for the consideration aforesaid the undersigned do hereby grant and convey unto said corporations and their respective successors and assigns, the right and easement to flood so much of the lands of the undersigned hereinafter described as may be flooded by the waters of said canal being raised at any time hereafter not to exceed two feet above the greatest height reached by said waters in the year 1918, as such height is now marked and established on the ground by markings on said canal, and this easement shall run with the land, which shall be and is hereby made at all times subject thereto; said land above conveyed and referred to being now described as follows:-

The north half of the southeast quarter of the southeast quarter of Section 16, Township 3 south, of Range 1 west of the Salt Lake Base and Meridian.

AGREEMENT

This agreement made and entered into this 18th day of October, 1919, by and between Reuben Snedaker, a single man, of Salt Lake City, Utah, the party of the first part, and Joseph H. Salisbury of Logan, Utah, party of the second part,

WITNESSETH: The party of the first part for the consideration hereinafter named hereby agrees to sell to the party of the second part the following described real estate in Salt Lake County, State of Utah:

Commencing at a point 27.07 rods West from the Northeast corner of Lot 3, Section 1, Township 2 South, Range 1 West, Salt Lake Meridian; running thence East 47.07 rods, thence South 1° East 27.04 rods, thence South 72° West to a point due South of the place of beginning, thence North to the place of beginning.

Also commencing 27.07 rods West from the Northeast corner of Lot 3, Section 1, Township 2 South, Range 1 West, Salt Lake Meridian; running thence West 8 rods, thence South 40 rods, thence East 8 rods, thence North 40 rods to the point of beginning.

Also commencing at the Southwest corner of the Southeast quarter of Section 36, Township 1 South, Range 1 West, Salt Lake Meridian, thence North 30 rods, thence East 19 4/5 rods more or less, to the center of a 4 rod street, thence South 1° East 17 rods along the center of said street, thence West 16 rods, thence South 10 rods, thence East 16 rods, thence South 3 rods, to the S. line of said section, thence West 20 rods more or less to the place of beginning.
