THIRD AMENDMENT OF DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CENTENNIAL INDUSTRIAL PARK (PHASE V)

This Third Amendment to the Declaration of Covenants, Conditions and Restrictions, made this 6th day of March 1986, by Union Pacific Land Resources Corporation, a Nebraska corporation, hereinafter referred to as "Grantor";

WITNESSETH:

WHEREAS, Grantor recorded a Declaration of Covenants, Conditions and Restrictions covering an industrial park known as Centennial Industrial Park (Phase V) on August 3, 1979, in Book 4915, beginning at page 795 as Entry No. 3317190, a First Amendment was recorded June 25, 1980 in Book 5116, beginning at page 387, as Entry No. 3447409, and a Second Amendment was recorded October 17, 1980, in Book 5166, beginning at page 371, as Entry No. 3491728, in the office of the Salt Lake County Recorder; and,

WHEREAS, Grantor desires to clarify Section IV relating to Restrictions and Requirements on Improvements by adding thereto a provision whereby buildings in Lots 11, 12, 13 and 14 may be protected by fire retardant materials or by a sprinkler system as is presently required.

NOW, THEREFORE, the Grantor hereby declares that the Declaration of Covenants, Conditions and Restrictions heretofore recorded as heretofore amended is further amended by revision of Section IV(m) to read as follows:

Additional Requirements for Lots 11, 12, 13 and 14 - Fire protection by sprinkler systems or fire proof building materials approved by the Salt Lake City Fire Department will be required for buildings in Lots 11, 12, 13 and 14 in CIPP-V.

Except as modified by this Third Amendment, the Declaration of Covenants, Conditions and Restrictions as modified by the First Amendment and Second Amendment remains in full force and effect according to the terms hereof.
