THIS AMENDMENT TO CERTIFICATE OF USE RESTRICTIONS, dated as of the 4th day of April, 1986, is made by those parties whose signatures are affixed hereto.

## Recitals

A. By Certificate of Use Restrictions (the "Certificate"), dated July 23, 1954, and recorded July 23, 1954, as Entry No. 1382411 at Book 1108, Page 438, in the records of the Salt Lake County Recorder's Office, Salt Lake County, State of Utah, certain restrictive covenants were imposed on owners of subdivided lots in Charleston Place Subdivision located in Salt Lake County, State of Utah, and more particularly described as follows:

Beginning at a point which is 389.43 ft. South and 241.63 feet West from the Northeast corner of the Southeast 1/4 of Section 16, T.2S., R.1E., S.L.B.&M. and running thence S. 0°23'30" W. 164.90 feet; thence N. 85°03'48" W. 311.23 feet; thence South 149.27 feet; thence N. 86°22'25" W. 1285.35 ft.; thence N. 1°30'20" E. 338.50 ft.; thence S. 85°13'45" E. 1590.60 ft., to the point of beginning (the "Subdivision").

- B. Paragraph (1) of the Certificate prevents the building of other than a single family one-story dwelling with a private garage on any lot of the Subdivision.
- C. Gayle Winterrose currently owns an unimproved lot within the Subdivision. He intends to sell such lot to a

party wishing to construct a single family two-story dwelling with a private garage on such lot.

- D. Paragraph (14) of the Certificate allows any covenants contained therein to be changed in whole or in part by an instrument, signed by a majority of the owners of the lots within the Subdivision.
- F. Each of the undersigned, as an owner of property in the Subdivision, desires to modify paragraph (1) of the Certificate to allow the construction of a single family two-story dwelling with a private garage on the lot currently owned by Gayle Winterrose.

## Amendment

THEREFORE, for adequate consideration, the receipt and sufficiency of which are acknowledged, the undersigned agree and certify as follows:

1. Paragraph (1) of the Certificate is hereby amended by adding the following to the end thereof:

"Notwithstanding the foregoing provisions of this paragraph (1), the owner of the following described parcel of real property located in Salt Lake County, State of Utah, is permitted to construct a single family two-story dwelling and private garage on such real property:

## PARCEL "A"

All of Lot 1 Stanida Subdivision, according to the official Plat thereof, on file in the office of the Salt Lake County Recorder, excepting therefrom the following: Beginning at the most Southerly corner of said Lot 1 and

## PARCEL "B"

Beginning at the Northeast corner of Lot 7, Charleston Place, according to the official plat thereof, on file in the office of the Salt Lake County Recorder, and running thence N85°13'45"W 175.00 feet; thence S1°30'20"W 141.19 feet; thence S89°58'35"E 167.53 feet; thence N4°46'15"E 127.09 feet to the point of beginning. Containing 0.527 acres."

2. Except as expressly provided herein, this document shall have no effect on the Certificate or any amendment thereto made before or after the date of this document.
