

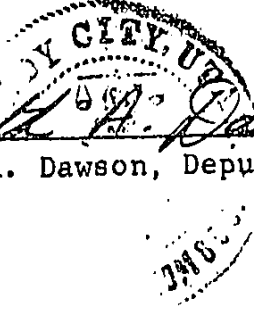

ORDINANCE #86-20

AN ORDINANCE TO CHANGE THE NAME OF A STREET 2195 EAST AND 10300 SOUTH BY ADDING THE NAME GRANITE MESA CIRCLE.

BE IT KNOWN AND REMEMBERED that the City Council of Sandy City, State of Utah, finds and determines as follows:

1. The property owners of property located on the street presently known as 2195 East and 10300 South have petitioned the Sandy City Council to change the name of that street by adding the name of Granite Mesa Circle; and
2. A public hearing was held with regard to the proposed name change; and
3. The Sandy City Council is satisfied that there is good cause for such change of name and that such change will not be detrimental to the general interest and that such name change should be made.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Sandy City, State of Utah, that the street presently designated as 2195 East and 10300 South shall now and hereafter be known as Granite Mesa Circle, 2195 East 10300 South.
