David S.Murdock, grantor of Heber, Utah., Duchesne County, State of Utah, hereby give, grant and dedicate unto Duchesne County, a municipal corporation of the State of Utah, its successors and assigns, for and in consideration of One Dollar and of the building of a public road over and upon the land herein described, a right of way and easement for a public highway known as a Federal Aid Highway, and for all proper Purposes connected with the use and enjoyment of the said premises as a public road so long as used for that purpose, the following tract of land in Duchesne County, State of Utah:

A triangular tract of land, said tract being within the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Sec.21, T.3 S. R 8 W., U.S.B. & M., and being more particularly described as follows to-wit:

"Beginning at the West $\frac{1}{4}$ corner of said Sec. 21, T 3 S., R 8 W., U.S.B. & M., thence north 17.8 ft; thence S 77° 13' E.80.6 ft; (Parallel to and 50 ft Northerly from the center line of the location of the State Highway); thence West 78.6 ft. to the point of beginning.

Said triangular tract of land contains 0.16 acres, more or less.

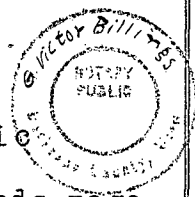

A strip or tract of land 100 ft in width, being 50 ft on each side of the center line of the location of the State Highway, said center line being within the NW $\frac{1}{4}$ SE $\frac{1}{4}$ and the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Sec. 21, T 3 S., R 8 W., U.S.B. & M., Duchesne County, Utah, and being more particularly described as follows, towit:

"Beginning at Survey Sta. 1191+27.0, a point in the East line of the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 21, aforesaid twp and range, which is approximately 950 ft South and 1332 ft West from the East $\frac{1}{4}$ corner of said Sec. 21; (Note: Tangent to curve at Survey Sta. 1191-27.0 has a bearing of N 71° 41' West) thence 276.6 ft around the arc of a curve to the left having a radius of 2864.9 ft.; thence N 77° 13' W 2457.9 ft to Survey Sta. 1218+61.5, a point in the West line
