Land Use Agreement

RECITALS. Circle Four Farms desires to secure adequate protection for drinking water wells located as shown in Exhibit A of this Agreement. More specifically, the locations of these wells are: Well # BMS1, located North 110 feet and East 521 feet, from the Southwest Corner of Section 7, Township 31 South, Range 13 West, Salt Lake Base and Meridian; Well # BMS2, located North 270 feet and East 715 feet from the South Quarter Corner of Section 7, Township 31 South, Range 13 West, Salt Lake Base and Meridian; and Well # BMS3, located South 2,349 feet and East 240 feet from the North Quarter corner of Section 18, Township 31 South, Range 13 West, Salt Lake Base and Meridian. For the purposes of this Agreement, Zones 1 and 2 encompassing the above referenced wells are identified as shown in Exhibit A and includes those portions which partially lie within the Grantors land, specifically within the South ½ of Section 7, Township 31 South Range 13 West, Salt Lake Base and Meridian, and those portions shown in the East ½ of Section 18 Township 31 South, Range 13 West, Salt Lake Base and Meridian.

AGREEMENT.

Circle Four Farms (Grantor) acknowledges the Drinking Water Source Protection Plan(s) for the above referenced wells. Circle Four Farms agrees not to allow the location of any uncontrolled potential contamination sources, as defined in R309-600-6(1)(u) of the Utah Administrative Code within Zone 1. Circle Four also agrees not to locate or allow the location of any pollution sources as defined in R309-600-6(1)(t) of the Utah Administrative Code within Zone 2, unless design standards are implemented to prevent contaminated discharges.

The controls and limitations of this Agreement within Zones 1 and 2 are binding with all successors, heirs, and assigns for as long as the well is used for culinary purposes.
