ORDINANCE NO. 489

AN ORDINANCE OF SALT LAKE COUNTY, UTAH, CHANGING THE NAME OF A COUNTY STREET NAMED BELVA LANE LOCATED IN THE REYNOLDS SUBDIVISION IN SALT LAKE COUNTY (MAGNA), UTAH

The Board of County Commissioners of the County of Salt Lake ordains as follows:

SECTION 1. Salt Lake County Ordinance Number 489 is hereby passed and enacted as follows:

(1) The name of the Salt Lake County street or road named Belva Lane, also designated as 8600 West Street, located in the Reynolds subdivision, a recorded subdivision in Salt Lake County, Utah, (Magna area) is hereby changed and shall hereafter be known as Buccaneer Drive as to the part thereof running approximately North and South between 3100 South and 2700 South Streets, Salt Lake County, Utah. The aforesaid section of street shall also continue to be designated as 8600 West Street, as well as Buccaneer Drive, and shall be so shown on the public records and appropriate street signs of Salt Lake County, Utah.

(2) The foregoing name change is being made upon the petition therefor of the residents abutting the subject road acting in cooperation with and upon the initiation of the Senior Class of Cyprus High School and the Cyprus High School Associated Students.

(3) On March 13, 1975, a public hearing was held pursuant to a public notice thereof, published in accordance with law, to which hearing all interested persons were invited to attend and be heard with respect to the said name change. Pursuant to said hearing, the Board of Commissioners finds and is satisfied that there is good cause for the name change made hereby, that it will not be detrimental to the general interest, that neither the public nor any person will be materially injured thereby and that it should be made.

SECTION 2. This ordinance shall take effect 15 days after its passage and upon at least one publication in a newspaper published in and having general circulation in Salt Lake County, Utah.
