On November 11, 2016 the Assessor's Office was provided with a parcel map containing the description of acreage that was to be rolled out of greenbelt. Chris Robinson then contacted us and requested that we send him the rollback tax bills for the parcels which were described on that map, which included acreage from parcel 04-071-0-0022. The rollback taxes for this requested 4.083 acres was \$2,863.15 and was attached as requested. The lien for those rollback taxes was recorded on 11/23/2016, (See Entry # 439869).

On November 21, 2016 we were notified that the first map reported incorrect acreage for some of the parcels. We were provided with a corrected map showing that parcel 04-071-0-0022 really needed 13.51 acres rolled out of greenbelt. As a result, new rollback taxes were attached to this parcel and the original rollback taxes (\$2,863.15) were removed. In addition, the previous recorded lien of \$2,863.15 for the original 4.083 acres will also need to be removed.

No money is due the previous owner (Arimo Corporation) from these rollback taxes.
