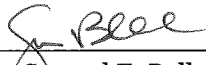
Duration: The duration of the reinvestment fee is perpetual.

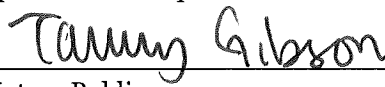

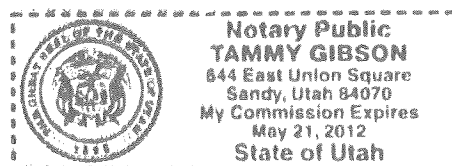
