Eat-A-Burger Ltd., and Daw, Incorporated, a Utah Corporation, of Salt Lake County, State of Utah, "Grantor", for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby grants and conveys to the Salt Lake County Water Conservancy District, a body corporate and politic of the State of Utah, "Grantee", and its successors and assigns, a perpetual pipeline easement and a temporary construction easement in those portions of Grantor's land situated in Section 29, Township 2 South, Range 1 East, Salt Lake County, State of Utah.

The easement hereby granted consists of perpetual right of ingress and egress to the land hereinafter described, together with the perpetual right to construct, reconstruct, operate, repair, replace and maintain a water pipeline and appurtenant structures over, under, across, and through a strip of land ten feet (10') in width, and a temporary construction easement to continue in effect for six (6) months from the date of execution hereof, over, under, across, and through an additional strip of land ten feet (10') in width, both easements being more particularly described as follows:

PERMANENT EASEMENT

A 10-foot easement, 5 feet on each side of the following described centerline:

Beginning at a point South 0^o04'01" West along the quarter section line 332.49 feet and West 880.01 feet from the North quarter corner of Section 29, Township 2 South, Range 1 East, Salt Lake Base and Meridian, said point of beginning also being on the east right-of-way line of 900 East Street; and running thence South 89^o38'44" East 134.17 feet.

Grantor shall have and maintain only a limited right to occupy and use the surface of the land burdened by the perpetual easement. Grantor shall not build or otherwise place opon the land burdened by this easement any permanent structure or building, or plant trees, shrubs, other plants or crops whose root zones would contact or interfere, in any way with Grantee's pipeline. Grantor shall have the right, however, to cross or cover the burdened land with sidewalks, curbs and gutters, roadways, driveways, fences, or other similar improvements, but only upon the written consent of Grantee, which consent shall not be unreasonably

withheld.
