DEED

UTAH LAKE IRRIGATION COMPANY and UTAH LAKE DISTRIBUTING COMPANY, both Utah corporations of Provo, Utah County, Utah, Grantors, hereby grant, bargain, sell, and convey unto DRAPER IRRIGATION COMPANY, a Utah corporation, of Draper, Salt Lake County, Utah, Grantee, for Ten (10) Dollars and other good and valuable consideration to Grantors in hand paid, the receipt whereof is hereby confessed and acknowledged, all of Grantor's right, title, and interest both in law and in equity in and to the following described property situated in Utah and Salt Lake Counties, in the State of Utah, to-wit:

(a) Grantor's rights under Application File No. 2136, filed in the office of the State Engineer of the State of Utah and approved by him and now of record in his office, to which record reference is hereby made, to the extent, but not in excess, of the right to divert thereunder from Utah Lake 65 second feet of water per second of time for the irrigation of lands described in said application, situated in Salt Lake County, Utah, and lying East of the Jordan River in said Salt Lake County.

(b) All that portion of a certain canal heretofore constructed and used by Grantor which is commonly called the Sandy Branch Canal of the Utah Lake Distributing Company, and which extends from a point on the main canal on the west side of the Jordan River of the system of canals now owned by grantors, a short distance north of the Jordan Narrows, across the Jordan River by means of a wood stave inverted siphon, and thence in a northeasterly direction past Draper, Utah, and to a point North and East of Sandy, Utah, which lies between the point where the same crosses the East bank of the Jordan River and the present end thereof near Sandy, Utah, together with all the lands and rights acquired by Grantor for right of way for said portion of said canal, all the pipes, gates, siphons, weirs, and other structures forming a part of or used in connection with said portion of said canal, and all other appurtenances of every kind and character belonging to, or used, occupied, or enjoyed in connection with said portion of said canal.

To have and to hold said property and all thereof unto the said Draper Irrigation Company and its successors and assigns forever.

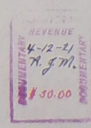

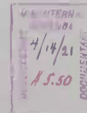
