THIS ACRESSENT, made and entered into this 20th day of Tangery, 1965, by and between The Ogden Union Railway and Depot Company, a corporation of the State of Utah, Grantor, and the State Road Commission of Utah, Grantee,

WITNESSETH:

That the Grantor, for and in consideration of the sum of EIGHT HUNDRED SEVENTI TWO AND NO/100 DOLLARS (\$672.00) to the Grantor paid by the Grantee, receipt of which is hereby acknowledged, hereby conveys unto the Grantee a temporary easement and right of way for the purpose of constructing thereon a channel relocation for Weber River and appurtenant parts thereof incident to the construction of a freeway known as Project No. 15-8, across portions of the property of the Grantor in the County of Weber, State of Utah, described as follows:

A rectangular tract of land situate in the SEt of NEt of Section 6, Township 5 North, Range 1 West of the Salt Lake Meridian, in Weber County, Utah, bounded and described as follows:

Commencing at the northwest corner of that certain first described tract of land which was heretofore conveyed by Thomas Russell, et al, to The Ogden Umion Railroad and Depot Company by warranty deed dated June 1624 feet, more or less, distant south and 1644 feet, more or less, distant west from the northeast corner of said Section 6;

thence East along the north line of said tract of land heretofore conveyed to The Ogden Union Railway and Depot Company by said deed dated June 27, 1942, a distance of 323.1 feet to the true point of beginning of the tract of land hereby being described;

thence continuing East along the north line of said tract of land heretofore conveyed to and Depot Company by said deed dated June 27, 1942, a distance of 150.0 feet;

thence South, at right angles, a distance of 242.0 feet;

thence West, at right angles, a distance of 150.0 feet;

thence North, at right angles, a distance of 242.0 feet to the true point of beginning.

After Weber River is relocated on above described part of an entire tract at the expense of said State Road Commission, said State Road Commission is thereafter relieved of any further claim or demand for costs, damages or maintenance charges which may accrue against said Weber River or appurtenant parts thereof, and upon the completion of such relocation this easement shall terminate and the State Road Commission of Utah shall have no further right, title or interest in the above described property.
