 the following described tract of land in Salt Lake County, State of Utah:

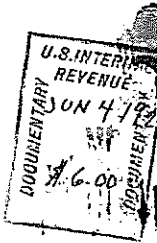

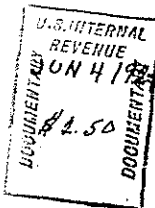
