NOTICE OF TRANSFER

NOTICE IS HEREBY GIVEN of actions taken by the Greenerhills Homeowner's Association (the "**HOA**") and the Twin Creeks Special Service District ("**TCSSD**"), pertaining to the Greenerhills Subdivision Plat, recorded in Wasatch County on September 7, 2000, in Book 474, Pages 575-704, Entry No. 227027 (the "**Plat**") and the Irrigation Water Right and Water System Transfer Agreement between TCSSD and the HOA, recorded in Wasatch County on September 21, 2015, in Book 1139, Pages 1836-1857, Entry No. 416332 (the "**Transfer Agreement**").

WHEREAS, the Plat states at Note 31 that irrigation water service is to be provided by the HOA, with TCSSD serving as the delivery agent;

WHEREAS, the Plat states at Note 35 that the HOA will be responsible for the pressurized irrigation system;

WHEREAS, in the Transfer Agreement, at Section 2.4, TCSSD agreed to be responsible for the Secondary Water System, which is the same pressurized irrigation system referenced at Note 35 in the Plat, upon the transfer of that system to TCSSD;

WHEREAS, the HOA transferred the Secondary Water System to TCSSD by Bill of Sale recorded in Wasatch County on September 8, 2014, in Book 1112, Page 159, Entry No. 404198 and TCSSD has in the past, and will continue in the future, to provide irrigation water service;

WHEREAS, the Plat states at Note 46 that the HOA and individual lot owners will be responsible for the maintenance and repair of the Jones Reservoir Dam;

WHEREAS, in the Transfer Agreement, at Section 3.2, the HOA assigned the responsibility for maintenance and repair of the Jones Reservoir, and all related facilities and equipment, to TCSSD, and TCSSD accepted that responsibility, subject only to the obligation of the Lot Owners (as defined in the Transfer Agreement) to pay a share of the cost of the maintenance and repair as set forth in the Transfer Agreement.

NOW THEREFORE, the HOA and TCSSD state as follows:

Note 31, Note 35, and Note 46 of the Plat no longer accurately state the obligations of the HOA or owners of the Property, as described on Exhibit A. Rather, those obligations were transferred to TCSSD as described above.

This Notice of Transfer does not alter, amend, modify, or change the Transfer Agreement in any way. If the terms of this Notice of Transfer conflict with any term of the Transfer Agreement, the Agreement will control.

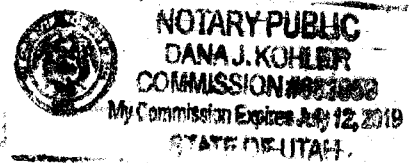

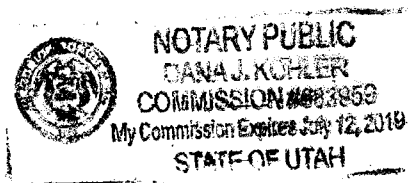
