Beg. at fence on North boundary line of grantor's land at a point 1350 ft. East, more or less, from the Northwest corner of Sec. 17, T. 2 N. R. 5 E. Beg. at fence on South boundary line of grantor's land at a point 1350 ft. East, more or less, from the Southwest corner of Sec. 8, T. 2 N.R.5 E. S.L. B. & M., th. running N. 12°44' W. 2333ft., th.
