

RIGHT OF WAY AND EASEMENT GRANT

a Corporation of the State of Utah, Grantor, does hereby convey and warrant to MOUNTAIN FUEL SUPPLY COMPANY, a Corporation of the State of Utah, Grantee, its successors and assigns, for the sum of ONE AND NO/100 DOLLARS (\$1.00) and other good and valuable considerations, receipt of which is hereby acknowledged, a right of way and easement to lay, maintain, operate, repair, inspect, protect, remove and replace pipe lines, valves, valve boxes and other gas transmission and distribution facilities (hereinafter collectively called "facilities"), said right of way being situated in the County of Salt Lake, State of Utah and more particularly described as follows, to-wit:

thence East 80.00 feet; thence on a curve to the right with a radius of 434.30 feet and a central angle of 19°00'00" for a distance of 144.02 feet (chord bears South 80°30'00" East 143.36 feet); thence South 71°00'00" East 25.00 feet; thence on a curve to the left with a radius of 252.91 feet and a central angle of 19°00'00" for a distance of 83.87 feet (chord bears South 80°30'00" East 83.48 feet); thence East 82.50 feet; thence on a curve to the left with a radius of 130.60 feet and a central angle of 25°00'00" for a distance of 56.98 feet (chord bears North 77°30'00" East 56.53 feet); thence on a curve to the right with a radius of 141.67 feet and a central angle of 29°00'00" for a distance of 71.71 feet (chord bears North 79°30'00" East 70.94 feet); thence South 86°00'00" East 13.50 feet; thence on a curve to the right with a radius of 595.28 feet and a central angle of 13°00'00" for a distance of 135.06 feet (chord bears South 79°30'00" East 134.77 feet); thence on a curve to the left with a radius of 230.32 feet and a central angle of 23°31'05" for a distance of 94.54 feet (chord bears South 84°45'33" East 93.88 feet); thence on a curve to the left with a radius of 25.00 feet and a central angle of 78°28'54" for a distance of 34.24 feet (chord bears North 44°14'27" East 31.63 feet); thence North 05°00'00" East 45.20 feet; thence South 68°59'53" East 27.04 feet; thence South 05°00'00" West 14.43 feet; thence on a curve to the left with a radius of 25.00 feet and a central angle of 108°00'00" for a distance of 47.12 feet (chord bears South 49°00'00" East 40.45 feet); thence North 77°00'00" East 9.69 feet; thence on a curve to the right with a radius of 454.84 feet and a central angle of 13°00'00" for a distance of 103.20 feet (chord bears North 83°30'00" East 102.98 feet); thence East 28.03 feet; thence on a curve to the left with a radius of 25.00 feet and a central angle of 90°00'00" for a distance of 39.27 feet (chord bears North 45°00'00" East 35.36 feet); thence North 10.00 feet; thence East 32.00 feet; thence South 170.00 feet to the point of beginning.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such facilities shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, inspect, protect, remove and replace the same. During temporary periods Grantee may use such portion of the property along and adjacent to said right of way as may be reasonably necessary in connection with construction, maintenance, repair, removal or replacement of the facilities. The said Grantor shall have the right to use the said premises except for the purposes for which this right of way and easement is granted to the said Grantee, provided such use does not interfere with the facilities or any other rights granted to the Grantee, hereunder.

The Grantor shall not build or construct nor permit to be built or constructed any building or other improvement over or across said right of way, nor change the contour thereof without written consent of Grantee. This right of way grant shall be binding upon and inure to the benefit of the successors and assigns of Grantor and the successors and assigns of the Grantee, and may be assigned in whole or in part by Grantee.

It is hereby understood that any parties securing this grant on behalf of the Grantee are without authority to make any representations, covenants or agreements not herein expressed.

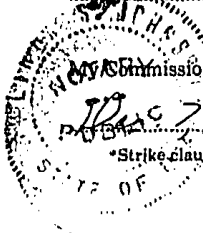
