### THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM

### OF THE SUGARPLUM PHASE II CONDOMINIUMS

This Third Amendment to Declaration of Condominium of the Sugarplum Phase II Condominium; ("Third Amended Declaration") is executed pursuant to the Utah Condominium Ownership Act (the "Act") and the original Declaration this \_\_\_\_\_ day of August, 1988 by SUGARPLUM ASSOCIATES, a joint venture ("Declarant").

### RECITALS

- A. Declarant has heretofore filed for record on January 16, 1985 a Declaration of Condominium ("Declaration") of the Sugarplum Phase II Condominiums with the Salt Lake County Recorder, as Entry No. 4039541, Book 5622, Pages 2266-2309, together with a Record of Survey Map ("Map"), Entry No. 4039540.
- B. The Declaration contains provisions for expansion of the Sugarplum Phase II Condominiums to include additional units within the Additional Land as defined in the Declaration.
- C. Pursuant to such expansion provisions, the Declarant executed the First Amended Declaration of Condominium of the Sugarplum Phase II Condominiums on December 16, 1985 ("First Amended Declaration"), recorded with the Salt Lake County Recorder as Entry No. 4180108, Book 5720, Pages 1917-1918. The Declarant subsequently executed a Second Amendment to the Declaration of Condominium of the Sugarplum Phase II Condominiums on February 23, 1988 ("Second Amended Declaration"), recorded with the Salt Lake County Recorder as Entry No. 4590120, Book 6006, Pages 1824-1828.
- D. Declarant desires by filing this Third Amended Declaration, together with a supplemental Record of Survey Map ("Supplemental Map") to correct certain ambiguities in the Second Amended Declaration by identifying H and I as units in the Village at Sugarplum, otherwise known as Part 3 Sugarplum Phase II Condominiums, and to expand Sugarplum Phase II Condominiums to include portions of the Additional Land, to be known as the Village at Sugarplum, Part 4 of Sugarplum Phase II Condominiums, and to adjust the percentages of undivided interest of all units in the Sugarplum Phase II Condominiums as permitted by the Declaration.

#### DECLARATION

- 1. Declarant hereby incorporates that portion of the Additional Land as described in Appendix B attached hereto and incorporated herein by this reference into the Sugarplum Phase II Condominiums, together with the two buildings located thereon containing a total of three units, and designated on the Supplemental Map as Units 21, J and K, which buildings are similar in construction to the original buildings described in the Declaration, and consist of two stories.
- 2. Declarant hereby designates on the Supplemental Map an additional building containing Units H and I, which was inadvertently and incorrectly omitted from the Second Amended Declaration.
- 3. Attached hereto and incorporated by reference is an amended Appendix A to the Declaration, which reallocates the undivided interest in the common areas and facilities among all Units in the Sugarplum Phase II Condominiums, including the Units described in the Declaration, the First Amended Declaration, the Second Amended Declaration, as well as Units added hereby all in accordance with Section 57-8-13.6 and 57-8-13.10 (2) of the Act.
- 4. Both this Third Amended Declaration and the Supplemental Map shall be considered supplemental to the Declaration, the First Amended Declaration, the Second Amended Declaration, and to the Map and any supplements or additions thereto, and except as expressly amended by this Third Amended Declaration and the Supplemental Map, the Declaration and First Amended Declaration, Second Amended Declaration and the Map and its supplements shall remain in full force and effect and shall not be cancelled, suspended or otherwise abrogated by the recording of this Third Amended Declaration and the Supplemental Map.
