DECLARATION OF ANNEXATION TO MEADOWS AT JESSIE'S BROOK, LLC PHASE 4

THIS DECLARATION OF ANNEXATION TO MEADOWS AT JESSIE'S BROOK is filed on the date evidenced below by Meadows at Jessie's Brook, LLC, as the Declarant ("Declarant" or "Jessie's Brook") of the subdivision pursuant to the Declaration (as defined below).

RECITALS

- A. Whereas, a Declaration of Covenants, Conditions and Restrictions for the Jessie's Brook Subdivision was recorded on August 27, 2019, as Entry No. 82955:2019 in the Recorder's Office for Utah, County (as may be amended from time to time, the "**Declaration**").
- B. Whereas, a Plat for Jessie's Brook Phase 4 was recorded on July 16, 2021, as Entry No. 2021-126098, in the Recorder's Office for Utah County ("Phase 4 Plat");
- C. Whereas, under Article VII of the Declaration, Declarant reserved an option to expand the Project (as defined in the Declaration) and annex additional property into the Project at any time.
- D. Whereas, Declarant is the fee simple owner of record of that certain real property known as Meadows at Jessie's Brook Phase 4 described with particularity on <u>Exhibit A</u> attached hereto and incorporated herein by this reference ("**Phase 4**") with authority to annex the property described herein.
- E. Whereas, the undersigned desires to expand the Project by annexing the Phase 4 Additional Property into the Project.

NOW THEREFORE, Declarant hereby declares as follows:

- 1. The Phase 4 Additional Property, as described in Exhibit A, is hereby submitted to the provisions of the Declaration and, pursuant thereto, is hereby annexed into the Property, as "Property" is defined in the Declaration, and is to be held, transferred, sold, conveyed, and occupied as a part of the Project.
- 2. Except as amended by the provisions of this Declaration of Annexation, the Declaration shall remain unchanged, and together with this Declaration of Annexation shall constitute the covenants, conditions and restrictions for the Property.

BEGINNING AT A POINT BEING SOUTH 00°36'05" EAST, ALONG THE SECTION LINE, 557.75 FEET AND NORTH 89°40'00" WEST 54.88 FEET FROM THE WEST QUARTER CORNER OF SECTION 5, TOWNSHIP 8 SOUTH, RANGE 3 EAST, SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE SOUTH 04°53'20" WEST 199.25 FEET; THENCE NORTH 89°52'52" EAST 128.03 FEET; THENCE SOUTH 00°33'11" EAST 122.89 FEET TO A POINT ON A 15.00 FOOT RADIUS CURVE TO THE RIGHT; THENCE SOUTHWESTERLY 24.56 FEET ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 93°48'24", (CHORD BEARS SOUTH 46°21'09" WEST 21.91 FEET); THENCE SOUTH 02°15'59" EAST 59.05 FEET TO A POINT ON A 15.00 FOOT NON-TANGENT RADIUS CURVE TO THE RIGHT; THENCE SOUTHEASTERLY 23.08 FEET ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 88°09'45", (CHORD BEARS SOUTH 45°12'05" EAST 20.87 FEET); THENCE SOUTH 01°07'17" EAST 85.94 FEET TO THE NORTH LINE OF JESSIE'S BROOK PLAT "A" AS RECORDED ON APRIL 13, 2005 AS ENTRY NO. 39096:2005 IN THE UTAH COUNTY RECORDER'S OFFICE; THENCE, ALONG THE SAID NORTH LINE, THE FOLLOWING THREE (3) COURSES: (1) WEST 309.28 FEET, (2) SOUTH 41°34'16" WEST 111.71 FEET, (3) NORTH 80°00'00" WEST 115.98 FEET TO THE EAST LINE OF A 66.00 FOOT RIGHT-OF-WAY LINE OF UTAH SOUTHERN RAILROAD; THENCE ALONG SAID EAST LINE OF UTAH SOUTHERN RAILROAD, NORTHERLY 565.51 FEET ALONG THE ARC OF A 5813.00 FOOT RADIUS CURVE TO THE LEFT, THROUGH A CENTRAL ANGLE OF 5°34'26", (CHORD BEARS NORTH 06°55'43" EAST 565.29 FEET); THENCE SOUTH 89°40'00" EAST 314.22 FEET TO THE POINT OF BEGINNING.
