

TRANSMISSION LINE EASEMENT

Jesse E. Millett and Bernice K. Millett
his wife, GrantorS., of Utah County, Utah, do hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission, distribution, telephone and telegraph circuits of the Grantee, and one 2-pole structure ~~swaps to tower~~ and no guy anchors with the necessary guys, stubs, cross arms, braces and other attachments affixed thereto, for the support of said circuits, on, under, over, through, and across a tract of land fifty (50) feet in width, located in Utah County, Utah, and being twenty-five (25) feet on each side of the following described center line:

Beginning on the north boundary line of the grantors' land at a point 885 feet south and 515 feet west, more or less, from the east one quarter corner of Section 27, T.5 S., R.2 E., S.L.M., thence S.27°48'E. 470 feet, more or less, to the south boundary line of said grantors' land and being in the NE 1/4 of the SE 1/4 of said Section 27.

The granting and accepting of this Easement revokes and cancels that certain Easement heretofore granted and accepted under date of August 5, 1948 and recorded December 4, 1948 in Book 509, page 389, as Entry 11718 in the office of the County Recorder of Utah County.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
