Quit Claims to STATE ROAD COMMISSION OF UTAH
grantee, of Salt Lake City , County of Salt Lake , State of Utah
for the sum of Seventy Five and no/100 ----- DOLLARS,
the following described tract of land in Weber County, State of Utah, to-wit:

A parcel of land in fee for an access road incident to the construction of a freeway known as Project No. 15-8, being part of an entire tract of property, in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 24, T. 6 N., R. 2 W., S.L.B.&M. Said parcel of land is contained within two side lines parallel to and at distances of 16.5 ft. southwesterly and 16.5 ft. northeasterly from the center line of said access road. Said center line is described as follows:

Beginning at the intersection of the easterly boundary line of said entire tract and said center line approximately at Engineer Station 30+46, which point is approximately 695 ft. north and 585 ft. west from the SE. corner of said Section 24; thence N. 44°35.4' W. 85 ft., more or less, to the intersection of said center line approximately at Engineer Station 31+31 and the westerly boundary line of said entire tract as shown on the official map of said project on file in the office of the State Road Commission of Utah. The above described parcel of land contains 0.06 acre, more or less.

Any and all water rights pertaining to the above described land are hereby reserved by the Grantor, and the Grantee shall not be liable for any water assessments now due or which shall become due.

This Deed is given pursuant to a resolution of the Board of County Commissioners of said Weber County passed on the 8th day of March A. D. 19 66 and is hereby given to convey all the right, title and interest acquired by Weber County. ~~xxxxxx~~
