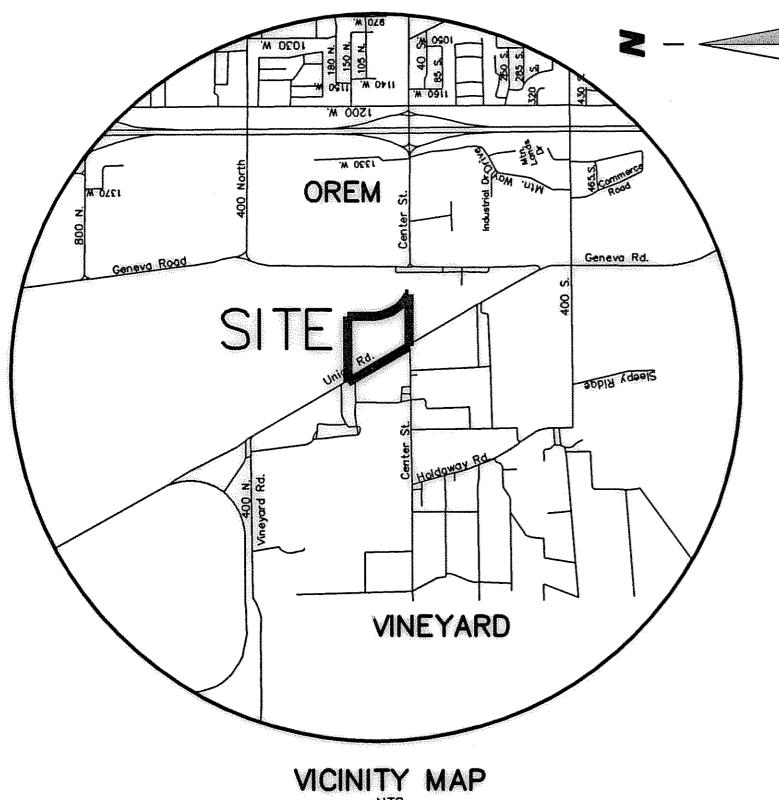

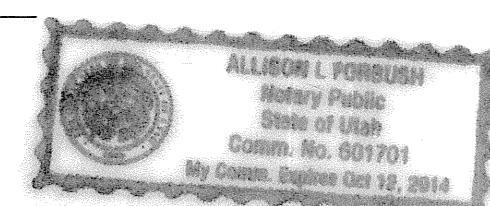

BOUNDARY DESCRIPTION

A PARCEL OF LAND LOCATED IN THE NORTH EAST QUARTER OF SECTION 17, TOWNSHIP 6 SOUTH, RANGE 2 EAST, SLB&M, VINEYARD, UTAH, SAID PARCEL BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE WEST QUARTER CORNER OF SAID SECTION 17; THENCE N.01°32'24"E, ALONG THE SECTION LINE A DISTANCE OF 258.25 FEET; THENCE EAST A DISTANCE OF 4,088.96 FEET TO A POINT ON THE EASTERLY RIGHT OF WAY OF THE UNION PACIFIC RAILROAD SAID POINT ALSO BEING THE REAL POINT OF BEGINNING;

THENCE N.30°04'07"W, A DISTANCE OF 1079.72 FEET ALONG SAID RAILROAD RIGHT OF WAY; THENCE N.89°26'03"E, A DISTANCE OF 832.25 FEET; THENCE S.00°33'57"E, A DISTANCE OF 392.79 FEET TO A POINT OF CURVATURE OF A 799.00-FOOT RADIUS TANGENT CURVE TO THE LEFT; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE A DISTANCE OF 199.27 FEET, SAID CURVE HAVING A CENTRAL ANGLE OF 141°7'21" AND A CHORD THAT BEARS S.07°42'37"E, A DISTANCE OF 198.75 FEET TO A POINT OF CURVATURE OF A 87.14-FOOT RADIUS TANGENT CURVE TO THE RIGHT; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE A DISTANCE OF 6.10 FEET, SAID CURVE HAVING A CENTRAL ANGLE OF 4°00'41" AND A CHORD THAT BEARS S.12°50'57"E, A DISTANCE OF 6.10 FEET; THENCE S.10°50'25"E, A DISTANCE OF 77.92 FEET TO A POINT OF CURVATURE OF A 113.00-FOOT RADIUS TANGENT CURVE TO THE LEFT; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE A DISTANCE OF 22.81 FEET, SAID CURVE HAVING A CENTRAL ANGLE 11°33'54" AND A CHORD THAT BEARS S.16°37'25"E, A DISTANCE OF 22.77 FEET TO A POINT OF CURVATURE OF A 810.95-FOOT RADIUS TANGENT CURVE TO THE LEFT; THENCE SOUTHEASTERLY ALONG THE ARC OF SAID CURVE A DISTANCE OF 84.86 FEET, SAID CURVE HAVING A CENTRAL ANGLE 5°59'45" AND A CHORD THAT BEARS S.25°24'16"E, A DISTANCE OF 84.86 FEET; THENCE N.66°34'46"W, A DISTANCE OF 361.36 FEET; THENCE S.59°59'38"W, A DISTANCE OF 56.71 FEET TO SAID POINT OF BEGINNING.
