AN ORDINANCE, AMENDING TITLE 19, ENTITLED "ZONING" OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 1986, BY RECLASSIFYING CERTAIN PROPERTY LOCATED IN SALT LAKE COUNTY FROM R-2-8 ZONE TO C-2/ZC ZONE.

URDINANCE:

The Board of County Commissioners of Salt Lake County, State of Utah, ordains as follows:

Section 1: Section 19.06.020, The Zoning Map of Salt Lake County, Code of Ordinance 1986, is hereby amended, as follows:

The property d scribed in Application #PL-88-4070, Smith Brubaker, and located within Salt Lake County, is hereby reclassified from R-2-8 Zone to C-2/zc Zone, said property being described as follows:

Beginning at a point 1699.2 ft. East and 483.1 ft. South from the Northwest Corner of section 29; Township 2 South, Range 1 East Salt Lake Meridian; thence North 63° 08' 40" West 86.06 ft.; Thence South 34° 04' 53" West 127.08 ft.; Thence Southwesterly along a 50 ft. radius 54 ft.; thence Southeasterly 15 ft, thence South 6° 09' 30" West 53.98 ft. to a reside which is corner and 1512.34 ft. Foot from point which is approximately 651.50 ft. South and 1512.34 ft. East from the Northwest corner of said section 29; thence North 85° 21' 20" East along a right of way line approximately 194.38 ft.; thence North approximately 180 ft. to the point of beginning. Also including the area to the center line of Fort Union Blvd. & 9th East which abuts this property.

Section 2: The map showing such change shall be filed with the Salt Lake County Planning Commission in accordance with Section 19.06.020 of the Salt Lake County, Code of Ordinances, 1986.

Section 3: This ordinance shall take effect fifteen (15) days after its passage and upon at least one publication in a newspaper published in and having general circulation in Salt Lake County, and if not so published within fifteen (15) days then it shall take effect immediately upon its first publication.
