AMENDMENT TO THE DECLARATION OF THE GEORGETOWN CONDOMINIUMS, October 31, 1988

The Management Committee, after consultation with Joseph Woodward, C.P.A., and Spencer Nilson, C.P.A.¹ feel that \$28.00 per month for Phase II owners achieves a fair and reasonable differential to compensate them for having paid their own air conditioning costs beyond condo dues and helping pay Phase I air conditioning costs through condo dues. The Committee also feels it is ensential that any agreement ultimately abolishes any difference between the payments of the two phases and the services rendered to the two phases. To this end, we submit this proposal for your vote:

- 1. Phase II homeowners are reimbursed beginning November 1, 1988, by having their monthly dues reduced \$19.46 each month.2
- 2. Each time a gas chiller is replaced, the Phase II reimbursement will be reduced by \$1.39. This will automatically be reflected in Phase II billings. When all gas chillers are replaced, payment differential will be eliminated.³
- 3. Repair and replacement of gas chillers will be paid from the general fund. Replacement will be swamp coolers.
- 4. Repair and replacement of electric air conditioners will be paid from the general fund. Replacement will be swamp coolers.
- 5. Phase II homeowners are given \$620 credit for not having received reimbursement since June, 1985. Those with balances due will have this amount deducted from that deficit. Those not with balances due will receive credit up to \$620 or \$15.00 per month for the length of time they have owned a Georgetown unit, whichever is less.4
- 6. Any balance due over \$620 will remain past due and the management committee will use methods available to them for collection.

I vote yes, no on this amendment.
