A G R E E M E N T

THIS AGREEMENT entered into this 11 day of November, 1989.

WHEREAS, on May 21, 1965 all of the owners of Diamond Acres Subdivision No. 1 (hereinafter the "Subdivision") caused certain protective covenants (the "Protective Covenants") to be recorded with the Salt Lake County Recorder's Office as Entry No. 2083847 in Book 2330, Page 392 relative to the following real property: All Lots in Diamond Acres Subdivision.

WHEREAS, the undersigned, being a majority of the lot owners within the Subdivision now desire to amend the Protective Covenants as set forth herein.

NOW THEREFORE, in consideration of the mutual covenants provided herein, the receipt and legal sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Amendment. Pursuant to paragraph H-1 of the Protective Covenants, the undersigned lot owners do hereby amend the Protective Covenants as follows: (a) The Property Description set forth in the first paragraph of the Protective Covenants shall be amended to read: "All lots in Diamond Acres Subdivision except for the real property known as Lot 31, Diamond Acres Subdivision No. 1, according to the official plat thereof on file and of record with the Salt County Recorder's Office."

It is the express intent of the undersigned property owners to vacate and remove all of Lot 31, of the Diamond Acres Subdivision No. 1 from the benefits and burdens provided in the Protective Covenants which have been previously recorded against the property.

2. Consent to Petition. The undersigned, through their execution of this Agreement do hereby consent to a petition to be filed with the Murray City Council or other applicable governing body to amend and vacate the subdivision plat applicable to the Diamond Acres Subdivision No. 1 to expressly exclude and vacate all of Lot 31, Diamond Acres Subdivision No. 1 from such plat. The undersigned do hereby specifically consent to such petition and to the filing of this Agreement with applicable governing bodies to evidence such consent.

3. Situs. This Agreement shall be construed in accordance with the laws of the State of Utah.



5. Counterparts. This Agreement may be executed in any number of identical counterparts, each of which shall be considered an original, but together shall constitute but one and the same agreement.
