FIRST AMENDMENT TO THE

DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CANYON VILLAGE-RUST PHASE 1 SUBDIVISION

The Declaration of Covenants, Conditions, and Restrictions for Canyon Village-Rust Phase 1 Subdivision (the "Declaration") was recorded as Document No. 467715 in the office of the Tooele County Recorder on May 14, 2018 against the following described real property within Tooele County, Utah:

WHEREAS, Article XIII, Section 8.5 provides that Declarant shall have and be vested with the right to unilaterally amend this Declaration as may be reasonably necessary or desirable under certain conditions, including the creation of condominiums on certain lots within the Subdivision; and,

WHEREAS, the Declarant currently retains sufficient control of lots within the Canyon Village-Rust Subdivision and is currently in the process of creating the Canyon Village-Rust Phase 1 Condominiums.

NOW THEREFORE, in accordance with the Declaration, and having the necessary authority, the Declaration is hereby amended as follows:

ARTICLE II, Section 2.9, shall be added in its entirety to the Declaration and shall hereafter read as follows:

2.9 Additional Declarations. It is anticipated that each of the Lots 122, 123, 124, 125, 126, and 127, shall, at the time condominiums are approved thereon, or within a reasonable time thereafter, have additional covenants, conditions, and declarations in addition to this Declaration that is specific to those lots. It is specifically the Declarant's intent that said lots shall have covenants, conditions, and declarations in addition hereto but not in contradiction to this Declaration.

The Declaration shall further be amended such that Lots 122, 123, 124, and 125 shall hereinafter be referred to, both for purposes of the Declaration and otherwise as "CANYON VILLAGE-RUST PHASE 1 CONDOMINIUMS. Any reference in the Declaration to lots 122, 123, 124, and 125 shall include and refer to as Canyon Village Rust Phase 1 Condominiums, including rights for assessments and other measures delineated in the Declaration applicable to the aforementioned lots.
