Beginning at a point that is located 1320 feet west and 779 feet North of the East 1/4 corner of Section 24 Township 2 South, Range 5 East, Salt Lake Base and Meridian; thence North 64° 48' East 661 feet to the P.C. of a 4° curve to the right; thence around the Arc of said curve 298.2 feet to the fence line of County Road; thence following along fence line in a Northerly direction 25 feet; thence westerly along said fence line 42 feet; thence South 64° 48' West 910 feet; thence South 20 feet; to the point of beginning.
