GRANT OF NON-EXCLUSIVE RIGHT-OF-WAY

This Grant of Non-exclusive Right-of-Way is made and entered into this $\frac{19^{14}}{100}$ day of April, 1990, by and between TRAVERSE MCUNTAIN, INC., an Arizona corporation ("TMI") and TRAVERSE ASSOCIATES, a Utah joint ventur: ("Associates").

RECITALS

WHEREAS, Associates is the owner of that certain parcel of property located in Salt Lake and Utah Counties, State of Utah, and which is described on Schedule 1 hereto (the "Associates Property").

WHEREAS, TMI is the owner of that certain parcel of property located in Utah County, State of Utah, which is described on Schedule 2 hereto (the "TMI Property").

WHEREAS, the Associates Property and the TMI Property were the subject of a lawsuit between RCP, TMI and Associates in the United States District Court, District of Utah, Central Division, Civil No. 90-C-0096-W (the "Lawsuit").

WHEREAS, in settlement of the Lawsuit, the parties have entered into a Stipulation and Settlement Agreement pursuant to which, among other things, Associates agreed to grant TMT a non-exclusive right-of-way over and across the Associates Property for the benefit of the TMI Property.

NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.00), the performance of the covenants and conditions contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties do agree as follows:

1. Right-of-Way: Associates hereby grants to TMI a perpetual non-exclusive appurtenant easement and right-of-way 50 feet in width over and across the southern portion of the Associates Property which abuts and is adjacent to the TMI Property, for the benefit of and to provide access and underground utilities to the north central portion of the TMI Property (the "Right-of-Way"). The Right-of-Way shall, at TMI's election, run either (i) from a point on the northern boundary of the TMI Property across the Associates Property to another point on the northern boundary of the TMI Property, or (ii) from the most practicably accessible roadway located on the Associates Property to a point on the northern boundary of the TMI Property. TMI and Associates acknowledge that the Right-of-Way has not been precisely or legally described, and that the exact location of the Right-of-Way shall be more specifically described by Associates at such time as either TMI or Associates is prepared to construct a road or install utilities thereon provided that

the Right-of-Way shall be in such location as will permit the construction of a road and the installation of utilities thereon in compliance with all government regulations concerning public roads and underground utilities. Associates further grants to TMI such reasonable temporary construction easements and slope easements along the Right-of-Way as may be necessary for the construction of improvements on the Right-of-Way pursuant to paragraph 2.

- 2. Improvements: Each of Associates and TMI shall have the right to construct, operate and maintain, at its own expense, any and all improvements within the Right-of-Wav which it deems necessary or desirable for the purpose of providing access, utilities and other benefits to the Associates Property or the TMI Property, including, but not limited to, a road, pavement, retaining walls, curbs, gutters, road lights, and sewer, water, electricity, telephone, gas and other utility transmission facilities, provided that all utilities shall be located underground unless otherwise consented to by Associates.
- 3. First Improvements: In the event either Associates or TMI decides to construct any improvements on the Right-of-Way (the "First Party"), such party shall notify the other party (the "Other Party") of such decision and of the nature and, in the case of utilities, the capacity of the intended improvements and the Other Party, at the Other Party's expense, shall have the right to direct the First Party to add to such improvements or to expand such capacity, with the cost of such addition or expansion to be born by the Other Party, so long as the Other Party provides the First Party with a surety bond or other guaranty acceptable to the First Party which will guarantee the payment by the Other Party for the cost of such addition or expansion and so long as such addition or expansion will not significantly delay the installation of the improvements to be installed by the First Party.
- 4. Additional Grants of Easement: Each of Associates and TMI may freely grant perpetual non-exclusive easements and rights-of-way over and across the Right-of-Way for the benefit of subdivisions of the Associates Property or the TMI Property and the owners and invitees of the subdivision parcels. Associates and TMI shall also each have the right to dedicate the Right-of-Way for public roadway purposes to Utah County or other applicable governmental authority.
- 5. Connection to and Use of Road on Right-of-Way: In the event TMI constructs a road on the Right-of-Way, Associates shall have the right to connect onto and use such road as access to the Associates Property at as many points as shall be necessary to facilitate the development of the Associates Property.

6. Run with the Land: The Right-of-Way shall run with the land as an encumbrance on the Associates Property and for the benefit of the TMI Property. The rights and duties of each of the parties hereto shall inure to the benefit of and be binding upon the respective successor owners of the TMI Property and the Associates Property.
