

That right of access for the purpose of a dedicated city street to said frontage roadway at a point directly northerly opposite Highway Engineer Station 75+26.00, said point is also approximately 140.32 feet S.89°53'41"W. along the Section line and 254.45 feet North from the East Quarter Corner of said Section 3.



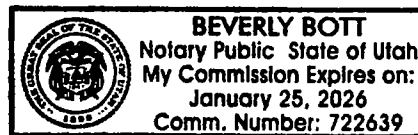
