xxxxxx, grantor(s), for and in consideration of Ten and No/100 ----- Dollars, and other valuable consideration, receipt of which is hereby acknowledged, do hereby grant, bargain, sell, convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, Grantee, its successors and assigns, a perpetual easement and right of way for the construction, erection, operation and continued maintenance, repair, alteration, inspection, relocation, and/or replacement of a wood pole or steel tower line or lines for the transmission, distribution, telegraph and telephone circuits of the Grantee, and one tower structure(s) together with necessary cross-arms and attachments, with no guys including stubs and anchors, affixed thereto, for the support of said circuits, in, upon, along, over, through, across and under a tract of land 150 feet in width, situated in the County of Weber, State of Utah, particularly described as follows:

Beginning at a point 1625 feet East from the Northwest corner of Section 27, Township 7 North, Range 2 West, Salt Lake Base and Meridian, and running thence East a distance of 162 feet, more or less, thence South Twelve Degrees, 57 minutes East a distance of 1360 feet, more or less, thence West a distance of 162 feet, more or less, thence North 12 degrees, fifty-seven minutes West, a distance of 1360 feet, more or less, to the place of beginning, all in the Northeast Quarter of the Northwest Quarter of Section 27, Township 7 North, Range 2 West, Salt Lake Base and Meridian.

Also, Beginning at a point 550 feet South and 423 feet West of the Northeast corner of the Southeast one fourth, of the Northwest one-fourth of Section 27, Township 7 North, Range 2 West, Salt Lake Base & Meridian and running thence West a distance of 154 feet, more or less, thence North 12 degrees 57 Minutes, West, a distance of 182 feet, more or less, thence North 30 degrees 00 Minutes East, a distance of 223 feet, more or less, thence South 12 degrees fifty-seven (57) Minutes East a distance of 382 feet, more or less, to the place of beginning, all in the South-east one-fourth of the NW 1/4 of Section 27, Township 7 North, Range 2 West, Salt Lake Base & Meridian.

This easement constitutes a grant of the right to construct a second transmission line within the above-described tract of land parallel to an existing transmission line; and this easement is granted in accord with and supplements a prior easement dated April 23, 1913, and recorded in the office of the County Recorder of Weber County, Utah, in Book H of Leases at page 473 & 507.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
